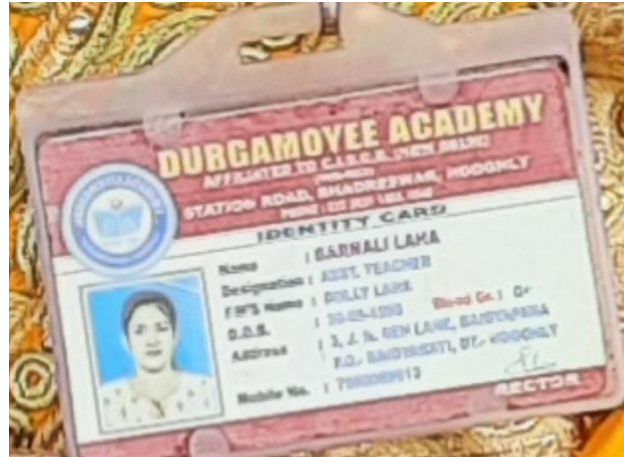

LETTER OF APPOINTMENT






